

Winter Storage Contract 2023 - Carp Agricultural Society

Early Bird Storage: Saturday October 14th @8AM
Regular Intake Storage: Saturday October 21st @8AM
Removal is Saturday April 20th at 8AM

This contract is for the winter storage of your vehicle, RV, or boat at the **Carp Agricultural Society** indoor storage facilities, located at 3790 Carp Road, Carp ON K0A1L0. Storage is provided on a first come, first served basis subject to the availability of space and Carp Fair Board of Director discretion.

Please fill out this form in full and include a copy of your insurance information. Bring this form with you to intake day on **Saturday October 21st, 2023, at 8AM.**

***Please DO NOT fill in the length, we will measure and calculate all items. Items will be rounded UP to the nearest foot in length.*

****Early Bird Storage is on October 14th, 2023 @ 8AM. Early bird is additional. \$200 to guarantee your spot, plus \$20.00 per foot for storage. Only 35 spots for early bird.***

The fee for regular winter storage 2023 is \$20.00 per foot.

RELEASE OF LIABILITY, WAIVER AND ASSUMPTION OF RISK

The undersigned hereby agrees that in consideration of my use of the Carp Agricultural Society storage space (the "storage"), I hereby agree to indemnify and hold harmless the Carp Agricultural Society, its elected and appointed officers and directors, officials, employees, agents and volunteers from any and all causes of action, claims, liabilities, obligations, judgments, losses or damages, including reasonable legal fees and costs of litigation ("claims") arising out of, or in connection with, my use of the storage. I further agree that neither I, nor any of my assignees, heirs, guardians, conservators, or legal representatives will make any claim against the "facility owner" arising from my use of the storage. The undersigned further recognizes the inherent risks of damage to, or loss of, any property associated with my use of the storage, arising from any cause whatsoever including, but not limited to fire, theft, vandalism, water damage, mysterious disappearance, rodents, acts of God, or the active or passive acts or omission or negligence of the Carp Agricultural Society.

The undersigned acknowledges such risks and hereby agrees to use the storage at my sole risk, excepting only loss, injury, damage, or costs that arise out of the Carp Agricultural Society's intentional wrongful acts or violations of law. I acknowledge the Carp Agricultural Society does not have insurance which applies to any property damage or loss whatsoever that I may suffer arising from my use of the storage. I acknowledge that should I not show up on the removal day list above, the Carp Agricultural Society has the right to cut off any lock(s) to remove my item(s). This item would then be left outside of the storage facility until it is picked up by the owner. I acknowledge I have the appropriate insurance in place and that I am solely responsible for obtaining any insurance desired at my own expense.

All items must be free and clear of any fluid leaks. If any fluid (including but not limited to; engine oil, gasoline, coolant) has leaked onto the floor during the tenancy of the storage rental agreement, the tenant will be held fully responsible for the clean up which will be completed by the Carp Agricultural Society and billed to the tenant in full.

I understand that the above rules and regulations apply and that breaking any rules will result in the cancellation of my storage rental and forfeiture of my security deposit. I also accept the terms of the Release of Liability, Waiver and Assumption of Risk above.
